**WAIVER OF LIABILITY, INDEMNIFICATION AND HOLD HARMLESS
& NAME AND LIKENESS GRANT**

The undersigned ("Participant"), in exchange for and as a condition of being allowed to participate in this and or any future 3-Gun event ("Event") at Ontelaunee Rod and Gun Club, agree as follows:

1. Assumption of Risk: Participant acknowledges that the Event involves the use of firearms and live ammunition and that there are certain risks associated with, and inherent in, the use of these products, including the possibility of serious bodily injury and death. Participant voluntarily and knowingly agrees to assume all risks, inherent or otherwise, that may arise out of or be in connection with Participant's participation in and presence at the Event, including without limitation the risk of serious bodily injury and death.

2. Waiver & Release of Liability: Participant covenants not to sue and agrees to release, waive, and discharge Ontelaunee Rod and Gun Club, 3-Gun, and each of their respective directors, officers, employees, agents, members, consultants, safety officers or volunteers (collectively, the "Released Parties"), from any and all claims, demands, suits, damages, settlements, and liabilities of any kind (including reasonable attorney's fees and dispute resolution costs) that Participant may suffer arising out of or in connection with Participant's participation in or presence at the Event, including the acts or omissions of other participants and/or any of the Released Parties.

3. Indemnity: To the extent allowed by law, Participant agrees to defend, indemnify and hold the Released Parties harmless from and against any and all claims, demands, suits, damages, settlements, and liabilities of any kind (including reasonable attorney's fees and dispute resolution costs) made by third parties arising out of Participant's acts or omissions preparatory to, during and in connection with the Event, including the acts of omissions of actual or alleged ordinary negligence of any of the Released Parties.
